Eligibility: Winners are typically selected based on **financial need and academics** with consideration also given to **character and leadership**. The candidate must be graduating from high school at the end of this current academic year and plan to enroll in a four-year college program commencing the next academic year. In addition, women who are presently matriculated into an undergraduate program may seek a one-year grant. Applicants must have maintained residency in Westfield for at least one year prior to applying. We encourage all young women to apply.

Monday, March 9, 2020 3:00 pm
to the Counseling Department Secretary at Westfield High School.
Applications that have missing documentation will not be considered.**

- The College Woman's Club Scholarship Application Form with reference
- Printed copy of the Common Application including Personal Essay
- Printed copy of a teacher recommendation
- High School Transcript (provided by the high school)
- Counselor's Letter of Recommendation (provided by the high school)
- One recent photo (photo optional for application, required if awarded scholarship)
- For current college student applicants, an official academic transcript and letter of recommendation from a faculty member are required.

To assess financial need, we also **require these items** enclosed in a separate sealed envelope:

- FAFSA form available through the high school guidance office or online.
- Latest two years' tax returns; preferably for years 2017 & 2018 including Schedules C and E, if applicable, from parent(s), and from the student, if filed.

Both the FAFSA and tax return components are referred to an outside agent for assessment of financial need and are not reviewed by the scholarship committee. FAFSA and tax information is for the exclusive use of the independent analyst and is **strictly confidential**.

After the initial review of applications by the committee, select candidates will be notified of the date and time of the mandatory interview with the selection committee. The interview will take place in April. Once the selection process has been completed, each candidate will be notified of the committee's decision regarding her application.

All winners will attend the College Woman's Club Annual Scholarship Dinner and Awards Ceremony to be held at in May of 2020, date to be determined. Recipients will be formally honored at that time. In addition, parents or guardians of honorees are invited to attend the awards presentations held immediately following the dinner.
